THE CARES PROJECT FOCUSES ON ONE-ON-ONE AND SMALL GROUP CONTACTS IN  
COMMUNITIES THAT ARE MEDICALLY UNDERSERVED AND/OR HAVE A HIGHER LEVEL  
OF LATE STAGE DIAGNOSIS OF BREAST CANCER THAT THE AVERAGE IN THE STATE  
OF FLORIDA. THE PROGRAM REACHED MORE THAN 8,000 WOMEN AND MEN IN JUST  
ITS FIRST YEAR. THE MASS PROGRAM (MAMMOGRAMS AFTER SUNDAY SERVICES) IS  
A SECOND OUTREACH EDUCATION PROGRAM PRIMARILY BUT NOT EXCLUSIVERLY TO  
THE AFRICAN-AMERICAN COMMUNITY THROUGH CHURCHES. DURING 2019-20, THE  
FOCUS WAS EXPANDED BEYOND SOUTH FLORIDA TO CENTRAL AND NORTHEAST

PERMITTING, THE IN-PERSON PROGRAMS WILL RESUME IN BOTH OF THESE NEEDED
